The meeting was called to order by Rev. Davies at 8:35 am on August 5, 2009, in the conference room at the FREDericksburg Regional Transit facility (a/k/a The Lawrence A. Davies Transit Center), 1400 Jefferson Davis Highway, Fredericksburg, VA.

The chairman called for the adoption of the minutes for the July 1, 2009, meeting. Mr. Pearce made a motion to approve the minutes as written, seconded by Mr. Moen, and the motion was passed unanimously by the Board.

The purpose of this meeting was to review the draft of the Mission, Goals and Objectives for Transit Year 2010. Several changes were noted and the revised document is attached hereto and made a part hereof.

Dr. Weinstock proposed that with the changes discussed, that this document be accepted. Mr. deLamorton made a motion to approve the Mission, Goals and Objectives with the changes and Ms. Utz seconded the motion. The vote to do so was unanimous.

Other Business:

- Mr. Levine gave a report on the July ridership, which will be incorporated into the City Council July Progress Report, a copy of which will be sent to the PTAB members.
- Mr. Levine also reported that he has recently been riding the FRED routes to take down mileage, and some of the drivers have suggested videotaping the routes so that drivers can refresh their memories about a route when they have not driven it for some time.
- Rev. Davies asked about how many deviations FRED receives a day and the reply was five to ten a day; they do slow down the system.
- Mr. deLamorton commented on his ride on the FRED bus; he was impressed with the radio traffic in trying to accommodate the passengers.


Announcements:
